Bees Bumper Draw - Terms and Conditions

1. Promoter

The Promoter of the Bees Bumper Draw is The Hive Foundation Limited, The Hive London, Camrose Avenue, London, HA8 6AG ("Foundation", "we", "our", or "us").

2. Eligibility

- 2.1 The prize draw is open to UK residents aged 18 or over only.
- 2.2 Employees of Barnet FC or the Foundation, and their immediate families, are not eligible to enter.
- 2.3 By entering, entrants confirm they are eligible and agree to be bound by these Terms and Conditions.

3. Entry methods and fees

- 3.1 Entry is via online subscription only, through the Barnet FC website.
- 3.2 Two subscription types are available:

Season subscription: £10/month - auto-entry to each draw during the 2025/26 season.

Monthly entry (ad-hoc): £15/month - single-entry per selected month, no automatic renewal.

- 3.3 All payments are non-refundable, including in the event of cancellation, disqualification, or failure to win.
- 3.4 Prices are subject to change at the discretion of the Foundation and subject always to prior notice.
- 3.5 By subscribing to the Bees Bumper Draw, entrants authorise the Foundation (or its authorised payment processor) to collect the applicable monthly subscription fee via the payment method or account details provided at the time of sign-up, or through any replacement payment system implemented by the Foundation from time to time.
- 3.6 The season subscription is a committed package covering the full 2025/26 season. Once subscribed, participants cannot cancel, pause, or obtain a refund for any part of the season, even if they choose not to participate in or claim any prizes.
- 3.7 The monthly entry (ad-hoc) may be cancelled at any time prior to the payment cut-off for the relevant monthly draw, but once payment is processed for any given month, it is non-refundable.

4. Draw schedule

- 9.1 Entrants' data will be processed in accordance with Barnet FC's Privacy Policy.
- 9.2 Winners may be asked to participate in publicity, including photography, video, or social media content, without additional compensation. Consent can be withdrawn at any time by contacting the Club.
